WHEREAS, the University of the Philippines Baguio continuously advertised the Invitation to Bid for the Procurement Project: SUPPLY AND DELIVERY OF BOOKS FOR UP BAGUIO with an approved Budget of Contract (ABC) in the amount of One Million Two Hundred Forty-Three Thousand Two Hundred Nineteen and 14/100 Only (Php 1,243,219.14) at the University of the Philippines Baguio website, the PhilGEPS, and in conspicuous places at the premises of the University of the Philippines Baguio from 11 October to 3 November 2021;

WHEREAS, on 3 November 2021, the scheduled bid submission and opening, MegaTEXT Phil., Inc. was declared as the sole calculated bidder (SLC) with a bid in the amount of Eight Hundred Twenty-Two Thousand, Seven Hundred Forty-Nine Pesos Only (Php 822,749.00);

WHEREAS, the project is composed of One Hundred Seventeen (117) items, however Megatext Phil., Inc. bid for One Hundred Two (102) Items only subjected for review and post-qualification;




NOW, THEREFORE, We the Members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
