**BAC RESOLUTION DECLARING SECOND FAILURE OF BIDDING FOR THE
PROCUREMENT PROJECT: SUPPLY, DELIVERY AND INSTALLATION OF
VARIOUS GENUINE SCIENTIFIC EQUIPMENT FOR UP BAGUIO, Bid Reference No.
UPB-BID-2022-07-B-NP**

RESOLUTION No. 2022-45

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, BAC Resolution No. 2022-42 was issued and approved on 06 December 2022 to declare second failure of bidding.

WHEREAS, Section 53.1 of the IRR of RA No. 9184, the Procuring Entity can directly negotiate a contract with a technically, legally, and financially capable supplier, contractor or consultant in cases where there has been failure of Competitive Bidding or Limited Source Bidding for the second time as provided in Section 35 of the above Act and same IRR:

WHEREAS, The Members of the Bids & Awards Committee University of the Philippines Baguio resorted to Negotiated Procurement under Section 53.1 (Two-Failed Biddings).

WHEREAS, the University of the Philippines Baguio re-advertised the Invitation to Bid for the Procurement Project: **SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SCIENTIFIC EQUIPMENT**, Bid Reference No. **UPB-BID-2022-07-B-NP**, with an approved Budget Contract (ABC) in the amount of **Two Hundred Twenty Thousand Pesos (PhP 220,000.00) Only**, at the University of the Philippines Baguio website, the PhilGEPS, BAC Bulletin Board and in conspicuous places at the premises of the University of the Philippines Baguio from 09 December to 16 December 2022;

WHEREAS, on 16 December 2022 was the scheduled opening and submission of bids, no prospective supplier submitted a bid;

WHEREAS, Section 53.1 (two-failed biddings) of the IRR of RA 9184, after failure of negotiated procurement, two (2) options are allowed; 1.) To conduct a second (2nd) Negotiated Procurement under Section 53.1 (two-failed biddings) of the IRR of RA 9184; or 2.) To conduct public bidding since the end-user modified the technical specifications of the Project, but without changing its ABC.

NOW, THEREFORE, for and in consideration of the foregoing, We the Members of the Bids & Awards Committee University of the Philippines Baguio, hereby RESOLVE as it is hereby RESOLVED:

- a. To declare a **failure of negotiated procurement** for the Procurement Project: **SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SCIENTIFIC EQUIPMENT FOR UP BAGUIO** with Bid Reference Number **UPB-BID-2022-07-B-NP**;
- b. To conduct a second (2nd) Negotiated Procurement under Section 53.1 (Two-Failed Biddings)
- c. To recommend for approval by the Head of the Procuring Entity, the Chancellor, the foregoing.
