BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT PROJECT: SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SURVEYING INSTRUMENTS FOR UP BAGUIO with Bid Reference No. UPB-BID-2022-07

## **RESOLUTION No. 2022-030**

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, the University of the Philippines Baguio continuously advertised the Invitation to Bid for the Procurement Project: SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SURVEYING INSTRUMENTS FOR UP BAGUIO, with an approved Budget Contract (ABC) in the amount of Eight Hundred Twenty Thousand Pesos Only (PhP 820,000.00), at the University of the Philippines Baguio website, the PhiliGEPS, and in conspicuous places in City Government of Baguio and Baguio City Public Market and at the premises of the University of the Philippines Baguio from 5 - 25 October 2022;

WHEREAS, on 13 October 2022 at 10:30 AM, the BAC conducted a Pre-Bid Conference for the procurement project at the Board Room to discuss, clarify and explain, among other things, the eligibility requirements and the technical and financial components of the contract to be bid but no prospective supplier attended the conference;

WHEREAS, on 25 October 2022 at 8:30 AM and 10:30 AM was the scheduled Submission and Opening of Bids, respectively. The deadline for submission of bids lapsed and no prospective supplier submitted a bid;

WHEREAS, under Section 35.1 (a) of the IRR of RA 9184, the BAC shall declare the bidding a failure when no bids were received;

**WHEREAS**, Section 35.2 of the same Act provides that in order to determine the reason of the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

**WHEREAS**, Section 35.3 of the same Act provides that the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or re-posting, as provided for in Section 21.2 of the IRR;

**WHEREAS**, upon review of the specifications and remarks from Dr. Javier, end-user & Project Leader of MULLAT-BLISS during the pre-bid conference that the item Automated Weather Station is more a scientific equipment rather than a surveying instrument, the BAC decided and approved that the said item will be separated from the other items to be bidded out;

WHEREAS, the project will be re-bidded with re-advertisement and/ or re-posting as two (2) separate procurement project;

**NOW**, **THEREFORE**, We the Members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- (a) To declare a failure of bidding for the Procurement Project: SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SURVEYING INSTRUMENTS FOR UP BAGUIO with Bid Reference No. UPB-BID-2022-07;
- (b) To have two (2) separate procurement project for the surveying instruments and scientific equipment;

(c) To recommend for approval by the Head of the Procuring Entity, the Chancellor, the foregoing
