**BAC RESOLUTION DECLARING CANCELLATION OF BIDDING FOR THE PROCUREMENT OF
TWELVE (12) MONTH- JANITORIAL SERVICES FOR CY 2023, Bid Reference No.
UPB-BID2022-EPA2023-01**

RESOLUTION NO. 2022-023

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, on 22 September 2022, the University of the Philippines Baguio - Bids and Awards Committee (UPB-BAC) Secretariat posted the Invitation to Bid for the Procurement Project: PROCUREMENT OF TWELVE (12) MONTH JANITORIAL SERVICES FOR CY 2023 with Bid Reference Number UPB-BID2022-EPA2023-01 at PhilGEPS, UP Baguio website, BAC bulletin board as well as in other conspicuous places within the premises of the university;

WHEREAS, the total Approved Budget for the Contract (ABC) for the project is Five Million Two Hundred Thirty-Two Thousand Nine Hundred Sixteen and 74/100 Pesos (Php 5,232,916.74) Only;

WHEREAS, on 30 September 2022 at 01:30 PM, the BAC held a Pre-Bid Conference at the Chancellors Boardroom and via Zoom platform to discuss the eligibility requirements and the technical and financial components of the contract to be bid. Two (2) prospective bidders namely ITREN Ventures Inc. and McKleene Premium Products Inc. attended the meeting;

WHEREAS, upon discussion and consultation with the prospective bidders, based on the Department of Labor and Employment-National Wages and Productivity Commission, there will be a wage increase in the Cordillera Administrative Region as per Wage Order No. CAR-21, effective 01 January 2023. The new minimum wage rate for CAR will be Four Hundred Pesos (Php 400.00);

WHEREAS, based on the 2022 Edition of the Department of Labor and Employment's Handbook on Workers' Statutory Monetary Benefits, the computation of Estimated Equivalent Monthly Rate (EEMR) of Monthly-Paid and Daily Paid Employees should be Two Hundred Sixty-One (261) days divided by twelve (12) months;

WHEREAS, that on the basis of the computation given, and after judicious evaluation, the ABC need to be adjusted for the procurement activity;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- (a) To recommend the cancellation of Bidding and to conduct Re-bidding with Re-posting of the Procurement Project: Procurement of Twelve (12) Month Janitorial Services for CY 2023 with Bid Reference Number UPB-BID2022-EPA2023-01;

(b) To recommend for approval by the Head of the Procuring Entity, the Chancellor, the foregoing.
