RESOLUTION No. 2022-53

BAC RESOLUTION DECLARING THIRD FAILURE OF NEGOTIATED PROCUREMENT FOR THE PROCUREMENT PROJECT: SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SCIENTIFIC EQUIPMENT FOR UP BAGUIO, Bid Reference No. UPB-BID-2022-07-B-NP2

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, **BAC Resolution No. 2022-45** was issued and approved on 16 December 2022 declaring a second failure of Negotiated Procurement for the project because no prospective bidder submitted theirs bi;

WHEREAS, Section 53.1 of the IRR of RA No. 9184, the Procuring Entity can directly negotiate a contract with a technically, legally, and financially capable supplier, contractor or consultant in cases where there has been failure of Competitive Bidding or Limited Source Bidding for the second time as provided in Section 35 of the above Act and same IRR:

WHEREAS, The Members of the Bids & Awards Committee University of the Philippines Baguio resorted to Negotiated Procurement under Section 53.1 (Two-Failed Biddings).

WHEREAS, the University of the Philippines Baguio re-advertised the Invitation to Bid for the Procurement Project: **SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE SCIENTIFIC EQUIPMENT FOR UP BAGUIO, Bid Reference Number UPB-BID-2022-07-B-NP2**, with an approved Budget Contract (ABC) in the amount of **Two Hundred Twenty Thousand Pesos Only (PhP 220,000.00)**, at the University of the Philippines Baguio website, the PhilGEPS, BAC Bulletin Board and in conspicuous places at the premises of the University of the Philippines Baguio from 29 December 2022 to 04 January 2023;

WHEREAS, on 04 January 2023, the scheduled opening and submission of bids, no prospective supplier submitted a bid;

WHEREAS, under Section 35 of the 2016 Revised Implementing Rules and Regulation (IRR) of RA 9184 provides that;

Sec. 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when

“a. No bids are received

xxx”;

NOW, THEREFORE, for and in consideration of the foregoing, We the Members of the Bids & Awards Committee University of the Philippines Baguio, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare a **Failure of Negotiated Procurement** in the Procurement Project: **SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS GENUINE**

SCIENTIFIC EQUIPMENT FOR UP BAGUIO with Bid Reference Number UPB-BID-2022-07-B-NP2;

- b. To recommend immediate purchase of the same item through Negotiated Procurement-Small Value under Section 53.9;
- c. To recommend for approval by the Head of the Procuring Entity, the Chancellor, the foregoing.
