

## Contract Agreement Form for the Procurement of Goods (Revised)

### CONTRACT AGREEMENT

THIS AGREEMENT made the 10<sup>th</sup> day of January 2023 between University of the Philippines Baguio of the Philippines (hereinafter called "the Entity") of the one part and Fil-Anaserve, Inc. of 2/F MRL Tower 124 Malakas St., Central District, Diliman, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply, Delivery & Installation of Various Genuine Laboratory Equipment for UP Baguio and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Three Hundred Ninety Eight Thousand Two Hundred Pesos (₱ 1,398,200.00) (hereinafter called "the Contract Price") broken down into two (2) source of funds as follows:


Revolving Fund	₱ 485, 200.00
Trust Fund	₱ 913, 000.00
<b>TOTAL</b>	<b>₱ 1, 398, 200.00</b>

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz :
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


3. In consideration for the sum of of One Million Three Hundred Ninety Eight Thousand Two Hundred Pesos (₱ 1,398,200.00) or such other sums as may be ascertained, Fil-Anaserve, Inc. agrees to Supply, Delivery & Installation of Various Genuine Laboratory Equipment for UP Baguio in accordance with his/her/its Bid. A copy of the offered items is hereto attached, marked as **Annex "A"**.
4. The University of the Philippines Baguio agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The place of delivery is at University of the Philippines Baguio.
6. In case of failure to make the full delivery within **Sixty (60) calendar days upon receipt of the Notice to Proceed**, a penalty of one-tenth (1/10) of one percent for every day of delay shall be imposed on the undelivered item/s.



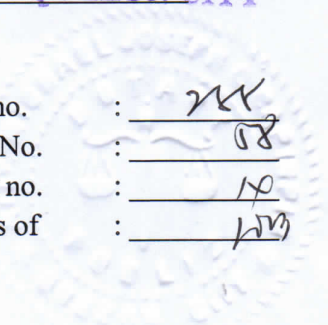
