RESOLUTION NO. 2022-040

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, the University of the Philippines Baguio continuously advertised the Invitation to Bid for the Procurement Project: : **SUPPLY AND DELIVERY OF PRINTED AND ELECTRONIC LEARNING RESOURCES FOR UP BAGUIO, BID REFERENCE NO. UPB-BID-2022-03-A**, with an approved Budget Contract (ABC) in the amount of **Nine Hundred Sixty Thousand Seven Hundred Fifty Three Pesos and Seventy Two Centavos (PhP 960,753.72)**, at the University of the Philippines Baguio website, the PhilGEPS, BAC Bulletin Board and in conspicuous places at the premises of the University of the Philippines Baguio from 15 October to 21 October 2022;

WHEREAS, on 26 October 2022 at 9:00 AM, the BAC conducted a Pre-Bid Conference for the procurement project at the Board Room to discuss, clarify and explain, among other things, the eligibility requirements, and the technical and financial components of the contract to be bid in which only one (1) prospective supplier namely Libtech Source Philippines, Inc. attended the conference via Zoom platform;

WHEREAS, ONE (1) bidder purchased bid documents namely: (1) Libtech Source Philippines, Inc.;

WHEREAS, on 7 November 2022, the scheduled submission and opening of bids only Libtech Source Philippines, Inc. submitted their bid;

WHEREAS, after opening the technical and financial component envelopes, the BAC declared the lone and their bid amounts are as follows:
