CONTRACT AGREEMENT

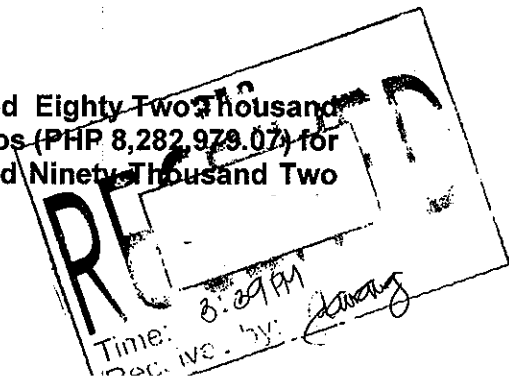
THIS AGREEMENT made the 28th day of December 2022 between University of the Philippines Baguio of the Philippines (hereinafter called "the Entity") of the one part and **ENFORCEMENT SECURITY AND INVESTIGATION INC., of No. 19 Fairlane Subd., Concepcion 1, Marikina City, Philippines** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of the Twelve (12) Month-Security Services** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eight Million Two Hundred Eighty Two Thousand Nine Hundred Seventy Nine Pesos and Seven Centavos (PHP 8,282,979.07)** for the period **January 1, 2023 to December 31, 2023** or **Six Hundred Ninety Thousand Two Hundred Forty Eight Pesos and Twenty Five Centavos Only (PHP 690,248.25) per month** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements; **Annex "A"**
 - ii. Technical Specifications; **Annex "B"**
 - iii. General **Annex "C-1"** and Special Conditions of Contract **Annex "C-2"**; and
 - iv. Supplemental or Bid Bulletins: **Annex "D"**
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical Proposal **Annex "E-1"** and Financial Proposal **Annex "E-2"**, and Cost Distribution as Calculated **Annex "E-3"**, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security; **Annex "F"**
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto **Annex "G"**; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
 - vi. University Rules and Regulations; **Annex "H"**
3. In consideration for the sum of **Eight Million Two Hundred Eighty Two Thousand Nine Hundred Seventy Nine Pesos and Seven Centavos (PHP 8,282,979.07)** for the period **January to December 2023** or **Six Hundred Ninety Thousand Two**


