**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SRCB)  
AND RECOMMENDING AWARD OF CONTRACT TO THUNDER GENERAL  
MERCHANDIZE FOR THE PROCUREMENT PROJECT: SUPPLY, DELIVERY AND  
INSTALLATION OF VARIOUS GENUINE AND NEW APPLIANCES AND  
ACCESSORIES FOR UP BAGUIO Bid Reference No. UPB-BID-2022-02**

**RESOLUTION NO. 2022-018**

**WHEREAS**, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

**WHEREAS**, the University of the Philippines Baguio through the Bids and Awards Committee (BAC) posted the Invitation to Bid for the Procurement Project: **SUPPLY, DELIVERY, AND INSTALLATION OF VARIOUS GENUINE AND NEW APPLIANCES AND ACCESSORIES FOR UP BAGUIO**, with an **Approved Budget Contract (ABC)** in the amount of **Two Million, Two Hundred Eighty-Four Thousand Pesos only (Php 2,284,000.00)**, at the University of the Philippines Baguio website, the PhilGEPS, and in conspicuous places at the University of the Philippines Baguio, as well as in other conspicuous places in Baguio City Hall and Baguio Public Market's bulletin board continuously for at least seven (7) calendar days starting 20 August 2022;

**WHEREAS**, on 31 August 2022 at 9:30 am, the BAC conducted a Pre-Bid Conference for the procurement project at the ODSA Conference Room, University of the Philippines Baguio and was attended by a representative from a prospective bidder, MCX Motor Corporation;

**WHEREAS**, pursuant to the said Pre-Bid Conference, the BAC issued one (1) Supplemental/Bid Bulletin announcing clarifications and amendments to the Bidding Documents on 5 September 2022. A copy of the Supplemental/Bid Bulletin is hereto attached, marked as **Annex "A"**;

**WHEREAS**, during the opening of bids held on 12 September 2022, the lone bidder, Thunder General Merchandize was declared compliant in both the Technical and Financial component during the preliminary examination of bids with a financial proposal in the amount of **Php Two Million, Two Hundred Forty-Two Thousand and Nine Hundred Pesos Only (Php 2,242,900.00)**;

**WHEREAS**, on 16 September 2022, representatives from the BAC, Secretariat and Technical Working Group (TWG), conducted an ocular inspection of Thunder General Merchandize office in San Fernando City, La Union to ascertain the statements and validate the documents submitted;

**WHEREAS**, on 20 September 2022, the Technical Working Group (TWG) presented to the BAC and Observers, the result of the post-qualification and reported that Thunder General Merchandize has complied with the technical specifications of the project and is responsive to all legal and technical documents for eligibility, marked as **Annex "B"**;


**WHEREAS**, the BAC unanimously agreed to declare the Lone Bidder eligible with the Single Calculated and Responsive Bid (SCRB) for the project;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


**INSTALLATION OF VARIOUS GENUINE AND NEW APPLIANCES AND ACCESSORIES FOR UP BAGUIO** with Bid Reference No. **UPB-BID-2022-02** with a contract price in the amount of **Two Million, Two Hundred Forty-Two Thousand, Nine Hundred Pesos (PhP 2,242,900.00) Only;**
