**RESOLUTION No. 2022-057**

**BAC RESOLUTION DECLARING ONE MERIT GLOBAL JANITORIAL SERVICES, INC. WITH THE LOWEST CALCULATED BID AND RESPONSIVE BIDDER AND RECOMMENDING AWARD FOR THE PROCUREMENT PROJECT: PROCUREMENT OF TWELVE (12) MONTH-JANITORIAL SERVICES FOR CY 2023, BID REFERENCE NO. UPB-BID2022-EPA2023-03**

**WHEREAS**, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

**WHEREAS**, the University of the Philippines Baguio continuously advertised the Invitation to Bid for the Procurement Project: **PROCUREMENT OF TWELVE (12) MONTH-JANITORIAL SERVICES for CY 2023, Bid Reference Number UPB-BID2022-EPA2023-03**, with an Approved Budget Contract (ABC) in the amount **Six Million One Hundred Ninety-Nine Thousand Two Hundred Thirty-Four Pesos and Seven Centavos Only (Php 6,199,234.07)**, at the University of the Philippines Baguio website, the PhilGEPS, BAC Bulletin Board and in conspicuous places at the premises of the University of the Philippines Baguio from 11 October to 18 October 2022;

**WHEREAS**, on 19 October 2022 at 9:00 AM, the BAC conducted a Pre-Bid Conference for the procurement project at the Board Room to discuss, clarify and explain, among other things, the eligibility requirements, and the technical and financial components of the contract to be bid in which eight (4) prospective suppliers namely: (1) McKleene Premium Products, Inc. (2) ITREN Ventures, Inc. (3) Dessert Manpower Services (4) One Merit Global Janitorial Serv, Inc. attended the conference;

**WHEREAS**, on 27 October 2022, pursuant to the said Pre-Bid Conference, the BAC issued one (1) Supplemental/Bid Bulletin announcing clarifications and amendments to the Bidding Documents;

**WHEREAS**, two (2) bidders purchased bid documents namely: (1) One Merit Global Janitorial Services, Inc., and (2) Mckleene Premium Products, Inc.;

**WHEREAS**, on 3 November 2022, the scheduled submission and opening of bids, both suppliers, One Merit Global Janitorial Services, Inc. and Mckleene Premium Products, Inc., Inc submitted their bids;

**WHEREAS**, after opening the technical and financial component envelopes, the BAC declared both bidders eligible and their bid amounts are as follows:

**WHEREAS**, on 16 December 2022, the BAC Secretariat and Technical Working Group (TWG) conducted an ocular inspection of One Merit Global Janitorial Services, Inc. office at UP Diliman and also visited the ongoing project at National Power Corporation located at Quezon City to ascertain the statements and validate the documents submitted;

**WHEREAS**, on 20 December 2022, the Technical Working Group (TWG) presented to the BAC and Observers, the result of the post-qualification and reported that One Merit Global Janitorial Services, Inc.

has complied with the technical specifications of the project and is responsive to all legal and technical documents for eligibility, marked as **Annex "A"**;

**WHEREAS**, the Technical Working Group (TWG) presented the bid evaluation for the financial proposals:


