INVITATION TO BID FOR SUPPLY AND DELIVERY OF SATELLITE IMAGES (UPB-GOODS-2023-04)

1. The University of the Philippines Baguio (UP Baguio), through the **Special Appropriations Act** intends to apply the sum of **One Million Nine Hundred Three Thousand Three Hundred Twenty Pesos Only (Php 1,903,320.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Satellite Images with Bid Reference No. UPB-GOODS-2023-04**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The University of the Philippines Baguio now invites bids for the above Procurement Project. Delivery of the Goods is required within **Thirty (30) calendar days upon conforme of the Notice to Proceed (NTP)**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **University of the Philippines Baguio** and inspect the Bidding Documents at the address given below from **Monday to Friday from 8:30AM to 4:30PM except holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders starting **26 April 2023 (Wednesday)** from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Two Thousand Pesos Only (Php2,000.00)**.

Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. In accordance with GPPB Circular 06-2005, the University of the Philippines Baguio adopt the use of "draw lots" as a tie-breaking method in the event two or more of the bidders have been declared as having the Lowest Calculated Responsive Bid (LCRB).
11. The **University of the Philippines Baguio** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
12. Bidders shall read the Bidding documents carefully and comply with the requirements indicated. Failure to comply may lead to disqualification of the bid.
13. Bidders are encouraged to properly use tabs and identify the documents submitted for ease of reference in the opening of bids.
