RESOLUTION NO. 2023-012

**BAC RESOLUTION RECOMMENDING THE CANCELLATION OF THE PUBLIC
BIDDING FOR THE PROCUREMENT PROJECT:
SUPPLY AND DELIVERY OF SPAGHETTI COIL MAT FOR UP BAGUIO
with Bid Reference No. UPB GOODS 2023-05**

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, the University of the Philippines Baguio continuously advertised the Invitation to Bid for the Procurement Project: **SUPPLY AND DELIVERY OF SPAGHETTI COIL MAT FOR UP BAGUIO**, Bid Reference Number **UPB GOODS 2023-05**, with an **Approved Budget for the Contract (ABC)** in the amount of **Five Hundred Fourteen Thousand Eight Hundred Pesos (Php 514,800.00) Only** at the University of the Philippines Baguio website, the PhilGEPS, and in conspicuous places at the premises of the University of the Philippines Baguio from 03 May 2023 to 11 May 2023;

WHEREAS, on 11 May 2023, Thursday, at 11:00 in the morning, the Bids and Awards Committee conducted a Pre-Bid Conference for the procurement project at the Chancellor's Board Room, University of the Philippines Baguio to discuss, clarify and explain, among other things, the eligibility requirements and the technical and financial components of the contract to be bid. There were no prospective bidders present;

WHEREAS, on the same day, through its Secretariat, received a letter from the end-user requesting for the cancellation of the existing procurement project on the purchase of spaghetti coil mat under PR#19431. The request for cancellation was made because of the need to review specifications and do additional market study.

WHEREAS, Section 35.6 (a) Rule X of the 2016 Revised IRR of R.A. 9184 states:

"Without prejudice to Sec. 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to:


- a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;"*

WHEREAS, considering the above provisions and upon deliberation, the BAC deemed it necessary that a cancellation of the subject procurement be considered by the Head of the Procuring Entity;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To recommend to the Head of the Procuring Entity, the cancellation of the Procurement Project: **SUPPLY AND DELIVERY OF SPAGHETTI COIL MAT FOR UP BAGUIO** with Bid Reference Number **UPB GOODS 2023-05**;
- b. Issue the Notice of Cancellation of the Procurement of Supplies and Delivery of Spaghetti Coil Mat for UP Baguio with Bid Reference# **UP-Goods-2023-05**.


