**BAC RESOLUTION DECLARING LINAR INTERNATIONAL BOOK RESOURCES, INC.,
SERV ENTERPRISES, AND MIND MOVER PUBLISHING HOUSE, INC. AS THE BIDDERS
WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND THE LOWEST
CALCULATED AND RESPONSIVE BID (LCRB), AND DECLARING A FAILURE OF BIDDING
AND RECOMMENDING APPROVAL OF REBIDDING OF THE 279 ITEMS WITH NO BIDS
RECEIVED FOR THE PROCUREMENT PROJECT: SUPPLY AND DELIVERY OF PRINTED
BOOKS FOR UP BAGUIO
with Bid Reference No. UPB-GOODS-2023-12**

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, the University of the Philippines Baguio continuously advertised the Invitation to Bid for the Procurement Project: **Supply and Delivery of Printed Books for UP Baguio with Bid Reference No. UPB-GOODS-2023-12**, with an Approved Budget for the Contract (ABC) in the amount of **Three Million One Hundred Ninety-Nine Thousand One Hundred Seventy-Eight Pesos and Forty Centavos Only (Php 3,199,178.40)**, at the University of the Philippines Baguio website, the PhilGEPS, and in conspicuous places at the premises of the University of the Philippines Baguio from 19 September 2023 to 10 October 2023;

WHEREAS, on 27 September 2023 at 8:30 a.m., the BAC conducted a Pre-Bid Conference for the project at the Chancellor's Board Room, University of the Philippines Baguio to discuss, clarify and explain, among other things, the eligibility requirements, and the technical and financial components of the contract to be bid. The conference was attended by representatives from prospective bidders in person and via Zoom namely: **F & J De Jesus, Inc., New Century Books, Golden Books Services, Inc., Belview Co., Inc., CD Books International, Inc., Global International Education Link Enterprises Co., and Fastbooks Educational Supply Inc.;**

WHEREAS, on 09 September 2023, the BAC issued Bid Bulletin No. 2023-01 that changes the date of submission from 05 October 2023 to 10 October 2023. A copy of the Supplemental/Bid Bulletin is hereto attached, marked as **"Annex A"**;

WHEREAS, on 04 October 2023 pursuant to the said Pre-Bid Conference, the BAC issued Supplemental Bid Bulletin No. 2 announcing clarifications and amendments to the Bidding Documents. A copy of the Supplemental Bid Bulletin is hereto attached, marked as **Annex "B"**;

WHEREAS, three (3) bidders purchased bid documents namely: (1) Linar International Book Resources, Inc., (2) Serv Enterprises, and (3) Mind Mover Publishing House, Inc.;

WHEREAS, on 10 October 2023 at 8:30 a.m., the scheduled submission and opening of bids, all three (3) bidders submitted their bids and were declared as "Eligible" and "Compliant";

WHEREAS, during the preliminary examination and reading of bids, the BAC declared the following:

WHEREAS, during the post-qualification period on 16 to 30 November 2023, upon careful examination, validation and verification of the eligibility, technical, and financial requirements that were submitted by Linar International Book Resources, Inc, Serv Enterprises, and Mind Mover Publishing House, Inc., all documents are in order and compliant. NOW, THEREFORE, We the Members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- (a) To declare **Linar International Book Resources, Inc., Serv Enterprises, and Mind Mover Publishing House, Inc.**, as the bidders with the **Single Calculated and Responsive Bid (SCRB)** for items specified and stated above for the project **Supply and Delivery of Printed Books for UP Baguio with Bid Reference No. UPB-GOODS-2023-12**;
- (b) To declare **Linar International Book Resources, Inc. and Serv Enterprises** as the bidders with the **Lowest Calculated and Responsive Bid (LCRB)** for item/s specified and stated above for the project **Supply and Delivery of Printed Books for UP Baguio with Bid Reference No. UPB-GOODS-2023-12**;
- (c) To recommend the Award of Contract for the project **Supply and Delivery of Printed Books for UP Baguio with Bid Reference No. UPB-GOODS-2023-12** to:
 - c.1. **Linar International Book Resources, Inc.**, for the items specified and stated above in the amount of **One Hundred Fifty-Four Thousand Six Hundred Eighty-Three Pesos Only (Php 154,683.00)**;
 - c.2. **Serv Enterprises**, for the items specified and stated above in the amount of **One Million Nine Hundred One Thousand Three Hundred Fourteen Pesos Only (Php 1,901,314.00)**; and


c.3. Mind Mover Publishing House, Inc. for the items specified and stated above in the amount of **Two Hundred Sixty-Seven Thousand Two Hundred Forty-Two Pesos Only (Php 267,242.00)**;

- (d) To declare failure of bidding for the 279 items with no bids received (enclosed, marked as **Annex "F"**) and to recommend for the rebidding with re-advertisement and posting of these items as provided for in Section 21.2 of RA 9184 and its IRR;
- (e) To recommend for approval by the Head of the Procuring Entity, the Chancellor, the foregoing;


