## **RESOLUTION No. 2023-071**

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT TO ABE GENERAL CONTRACTOR FOR LOT 1 AND LOT 2 OF THE PROCUREMENT PROJECT "CONSTRUCTION OF RETAINING WALL AND RAMP AT THE COLLEGE OF ARTS AND COMMUNICATION" with Bid Reference No. UPB-INFRA-2023-02A

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act (RA) 9184 and its Implementing Rules and Regulations (IRR), and that all procurement are conducted strictly according to specifications;

WHEREAS, the University of the Philippines Baguio through the BAC continuously advertised the Invitation to Bid for the Procurement Project, Construction of Retaining Wall and Ramp at the College of Arts and Communication with Bid Reference Number UPB-INFRA-2023-02A, with an Approved Budget for the Contract (ABC) in the amount of One Million Five Hundred Seventy Thousand Seven Hundred Pesos Only (Php 1,570,700.00), at the University of the Philippines Baguio website, the PhiliGEPS, and at the premises of the University of the Philippines Baguio starting 28 November 2023 to 19 December 2023.

WHEREAS, on 29 November 2023, the BAC issued Bid Bulletin No. 2023-01 announcing the change of venue of the Pre-Bid Conference from the Chancellor's Board Room to the ODSA Conference Room;

WHEREAS, on 05 December 2023 at 3:30 p.m., the BAC conducted a Pre-Bid Conference for the procurement project at the ODSA Conference Room, University of the Philippines Baguio to discuss, clarify and explain, among other things, the eligibility requirements, and the technical and financial components of the contract;

WHEREAS, on 19 December 2023 at 3:30 p.m., the scheduled bid submission and opening, the BAC received two bidding documents for Lot 1 and Lot 2 of the procurement project. Upon validation and verification of the legal, technical, and financial requirements submitted by the two bidders, JLG Construction was found to be ineligible due to submission of unnotarized bid declaration whereas ABE General Contractor was found to be eligible and compliant with a bid per lot as read:

WHEREAS, on 19 December 2023, the BAC issued a resolution declaring ABE General Contractor as the Single Calculated Bid (SCB) in the total amount of One Million Three Hundred Forty-Six Thousand Eight Hundred Twenty-Seven Pesos and Thirty-One Centavos Only (Php 1,346,827.31) and was recommended for post-qualification. A copy of BAC Resolution No. 2023-065 is hereto attached, marked as "Annex A". The calculated bid per lot is as follows:

WHEREAS, on 20 December 2023, ABE General Contractor was notified for post-qualification that was acknowledged on 21 December 2023;

WHEREAS, during the post-qualification period on 21 December 2023 to 28 December 2023, upon careful examination, validation and verification of the eligibility, technical, and financial requirements that Page 1 of 2

were submitted by ABE General Contractor, all documents are in order and compliant. Furthermore, during the ocular visit to their office, ABE General Contractor was found to be compliant and responsive. A copy of the Bids and Awards Committee-Technical Working Group's (BAC-TWG) Evaluation Report is hereto attached, marked as "Annex B";

NOW, THEREFORE, for and in consideration of the foregoing, We the Members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- (a) To declare ABE General Contractor as the bidder with the Single Calculated and Responsive Bid (SCRB) for Lot 1 and Lot 2 of the project "Construction of Retaining Wall and Ramp at the College of Arts and Communication";
- (b) To recommend the Award of Contract to ABE General Contractor for Lot 1 and Lot 2 of the project "Construction of Retaining Wall and Ramp at the College of Arts and Communication" with Bid Reference No. UPB-INFRA-2023-02A in the total amount of One Million Three Hundred Forty-Six Thousand Eight Hundred Twenty-Seven Pesos and Thirty-One Centavos Only (Php 1,346,827.31) with the following lot distributions:
  - Php 796,201.78 Lot 1. Construction of Retaining Wall at the College of Arts and Communication
  - Php 550,625.53 Lot 2. Construction of Ramp at the College of Arts and Communication
- (c) To recommend for approval by the Head of the Procuring Entity, the Chancellor, the foregoing.
