In view of the two (2) failed biddings, the *University of the Philippines Baguio* through its Bids and Awards Committee (BAC), invites PhilGEPS registered, technically, legally, and financially capable suppliers to participate in the *Negotiated Procurement under Two-Failed Biddings* for the *Supply and Delivery of Digital Terrain Model*, in accordance with Section 53.1 of the Revised Implementing Rules and Regulations of the Republic Act (RA) No. 9184.
- 2. The University of the Philippines Baguio, through the Special Appropriations Act CY 2023 intends to apply the sum of Nine Hundred Thousand Pesos Only (Php 900,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Negotiated Procurement under Two-Failed Biddings for Supply and Delivery of Digital Terrain Model with bid reference number UPB-GOODS-2023-08A. Proposal/quotation received in excess of the ABC shall be automatically rejected at opening.
- 3. The *University of the Philippines Baguio* will engage in negotiation with sufficient number of suppliers to ensure effective competition. The selection of the successful proposal shall be based on the best and final offer that will be submitted on the specified date shown on item no. 4 of this invitation, and which would meet the minimum technical specifications required attached Annex "A". Delivery of the Goods is required by **Thirty (30) calendar days** from receipt of the Notice to Proceed (NTP).

- 9. In accordance with GPPB Circular 06-2005, the University of the Philippines Baguio adopt the use of "draw lots" as a tie-breaking method in the event two or more of the suppliers have been declared as having the Lowest Calculated and Responsive Quotation.
- 10. The *University of the Philippines Baguio* reserves the right to reject any offer, to annul the negotiation process, and to reject all offers at any time prior to contract award, without thereby incurring any liability to the affected participants.
